

## Derby & Derbyshire Local Medical Committee Meeting Summary

### Items Discussed

#### *Welcome & Acknowledgements*

The Chair opened the meeting by thanking Dr Peter Holden for his 45 years of service as he steps down following his election as BMA Treasurer. His contribution was formally recognised by the committee.

#### *Financial Overview*

The 2025/26 budget was approved. Financial reserves are maintained to safeguard against future costs.

#### *Update from Nicki Doherty – ICB Context and Changes Ahead*

Nicki Doherty, Director of Place and Partnerships at the Integrated Care Board (ICB) provided an overview of upcoming structural changes and the evolving role of partnerships.

Nicki highlighted the need for clearer communication of Derbyshire's strategic narrative and outlined opportunities for collaboration between the ICB and the LMC. During discussion, concerns were raised about increasing complexity in general practice and the risk of GP burnout as responsibilities shift without adequate support. Nicki acknowledged these risks and stressed that empowering patients to navigate services effectively will be key to success.

#### *Unfunded Work*

The committee was updated on the unfunded work. The message to Practices is to concentrate on commissioned services and avoid non-core unfunded tasks for patient safety. Six priority areas were identified for pushback:

- Compression hosiery measurement
- Doppler assessments
- Chronic Lymphocytic Leukaemia monitoring
- Coeliac disease monitoring
- Specialist drug monitoring (gender dysphoria)
- Physical and blood monitoring for eating disorders

#### *Operational Updates*

Progress continues on developing Single Points of Contact (SPOCs) to resolve issues at the primary-secondary care interface. Practices are encouraged to use SPOCs for concerns such as inappropriate test requests or referral issues.
