Respiratory

NEW: Guidance regarding Spirometry/Respiratory Function Testing During Endemic COVID-19

[New guidance](#) via the Association for Respiratory Technology & Physiology (ARTP) and British Thoracic Society (BTS) has been released in relation to the confirmation that spirometry should not be undertaken for the foreseeable future. The guidance states that nearly all lung function tests, including spirometry are classed as an aerosol generating procedure (AGP). Spirometry is essential for assessment of obstructive lung diseases, coupled with the detailed assessments of gas transfer and cardiorespiratory exercise testing are essential for lung cancer. Spirometry coupled with gas transfer is needed in assessing interstitial lung diseases.

Conclusions from the above guidance have suggested that the following precautions must be in place:

- Full PPE should be used for undertaking testing; if this is not available tests should not take place
- Patient and staff safety is paramount, with the need to operate differently. Consider all patients to have COVID-19 infection
- “Routine” respiratory function testing should no longer occur in primary care practices unless part of a coordinated Hub, based around PCNs with all the appropriate precautions
- Recognise the inefficiencies to ensure patients are booked appropriately to allow the equipment to be cleaned. This may mean different time slots for different tests

This is an evolving field and more research into risks and procedures is needed. Hence, this document will be updated when such information becomes available.

Diabetes

Albumin Creatinine Ratios (ACRs) for people with diabetes

Derby, Chesterfield, Burton and Nottingham hospitals are all now able to process ACR samples. Many practices are giving out an ACR bottle and form at the time of a diabetes blood test and suggesting it can be posted through the practice letter box at a later date. It is not advised that a patient comes into the practice specifically to collect or deliver an ACR sample pot.

Cardiovascular Disease

CVD at CRH

Cardiology	New and follow up appointments currently by telephone. Some procedures suspended.
Cardiorespiratory	Spirometry & Echocardiogram - Inpatients only. Monitors - Urgent appointments only. Replacement kit managed via phone/email and posted out.

CRH and UHDB

There is a recognised need to ensure patients that need it are calling for an ambulance and / or getting to hospital to seek urgent medical attention for any chest pain experienced for longer than 15 minutes. The hospitals have seen a drop in attendances linked to heart attacks, strokes and other associated conditions since Covid. The NHS is still open for emergency care. GPs must go ahead with referrals for emergency care for relevant patients. The Consultant will make the decision about whether the patient needs to visit the hospital urgently or not.

Gastroenterology

For Gastro at CRH

Endoscopy suite	Only Inpatients and clinically urgent patients being seen.
Inflammatory Bowel Disease (IBD) Clinic	New and follow up appointments currently by telephone only.
Gastro – Daycase	Suspended although new referrals are being triaged.

IBD Clinics – CRH

All clinics are currently being run via telephone contact led by the IBD Lead Nurse. All high risk IBD patients have been contacted and supported via the IBD e-mail advice line service. Five clinics are being run per week which would usually be face to face but are now via telephone contacts. In addition, the two telephone clinics run prior to Covid are continuing.

The IBD MDT reviews are continuing and the lead IBD Nurse has been reviewing the complex patients and liaising with the MDT accordingly.

Infusions are being given on the NGS unit and patients can access the hospital via the back entrance. There has been very little disruption to the infusion service and most have attended as planned with reassurance and support.
