Premises Rent Increases

Issue 6

The GPC is investigating concerns raised by LMCs about reports received from PCTs that, from next year, rent increases for practices will not automatically be funded, and the further rumours circulating that PCTs will not continue to automatically review rents every three years.

The GPC believes that there is an unequivocal statement (para 42) in the NHS (General Medical Service - Premises Costs) (England) Directions 2004 which allows for this. This states that:

- 42. Where a PCT grants an application of the type mentioned in direction 41, subject to the following provisions of this Part, the amount that it must pay to a contractor in respect of notional rent is the current market rental value of its practice premises, as determined in accordance with Parts 1 and 3 of Schedule 2. The PCT must review this amount as part of a three yearly review of the contractor's notional rent, although this review may be brought forward if—
- (a) there is a change to the purposes for which the premises are used;
- (b) there is further capital investment in the premises, and payments are to be made to the contractor in respect of that investment under its GMS contract.

The Department are checking with their premises expert.

Unnecessary GP paperwork

A new campaign has been launched to remind patients that they don't need their GP to countersign passport applications or issue certificates for absence for short-term sick leave. Although this has been the case for several years, many patients are unaware that over 40 oth-



er professions can countersign passport applications and that "self certification" of absences of less than 7 days is allowed.

Posters will be sent to practices shortly.

QOF – Mental Health Indicator

The following changes have now been agreed to the Mental Health Indicator 5, i.e. "The percentage of patients on lithium therapy with a record of lithium levels in the therapeutic range within the previous 6 months".

- That the therapeutic range for serum lithium levels be changed to 0.4 1.0 mmol/l
- That the upper achievement threshold for this indicator be increased to 90%
- That these changes are introduced from April 2005

Practices are reminded that where practices have agreed a locally valid range for their PCOs for 2004-05, they will still receive all the appropriate QOF points. This is because QMAS has the ability for practices to raise issues about their final achievement on any particular indicator with the PCO. The PCO can then agree that the practice has met the achievement within the local range before the practice agrees to the final sign off.

Locum Fees

Derbyshire LMC recently conducted a survey of fees paid by practices to locums in Derbyshire. Unfortunately there are difficulties in publishing the results of this survey. In the past the BMA has published a range of suggested fees but in 2000 the Office of Fair Trading ruled that publication of these fees was anticompetitive in the context of the Competition Act 1988. Members of a cartel (an arrangement between two providers not to compete with each other, whether written or verbal, formal or informal) can be fined heavily if found to be arranging fees in any way. The BMA appreciates that employers and freelance GPs would welcome guidance on how to set their own fee and has set up a Working Group to produce clear guidance to support all parties involved in negotiating for GP freelance services.



Practice Based Commissioning – technical guidance

The Practice Based Commissioning guidance published in December promised further technical guidance to help practices and PCTs implement Practice Based Commissioning. The technical guidance was published on 23 February and provides information on establishing practice level budgets, risk management, use of efficiency gains, management costs and the values and principles underpinning Practice Based Commissioning.

However, the GPC believes that the document raises more questions than it answers. Although information is given on setting default budgets a lot of the decision making on financial allocations will take place at local level and information on how these decisions will be taken is not clear.

The guidance also explicitly links Practice Based Commissioning with the Choose and Book electronic referral system. The uptake of Choose and Book has been very low because many doctors fear that they system is not workable. Linking the two systems may act as a deterrent for practices to take on the new commissioning role.

The GPC will be producing its own guidance for doctors to help them get the necessary information from their PCTs to enable them to decide whether or not to take on the commissioning role.
