## DATA SECURITY AWARENESS TRAINING

## **GDPR: DATA PROTECTION OFFICER**



GDPR stands for the General Data Protection Regulations and is the new legislation which will be replacing the Data Protection Act 1998 on the **25<sup>th</sup> May 2018** 

GDPR will bring in some big

changes to the way we process and handle personal data.

One of the changes which is coming into force is the introduction of a new key role – The Data Protection Officer (DPO)

Each public authority must ensure that they have a DPO by the time that the legislation comes into force. Their main role is to ensure compliance with the legislation.

- The DPO will report to the highest management level of your organisation – ie board level.
- They must be able to operate independently and is not dismissed or penalised for performing their task.
- And adequate resources must be provided to enable DPOs to meet their GDPR obligations.

The DPO can be someone within the organisation or you can contract out the role, as long as their duties do not conflict (such as already being a SIRO or Caldicott Guardian).

Now is the time to start to think about who may fulfil this role in your organisation.

## IN THE NEWS

#### INTERNATIONAL RIGHT TO KNOW DAY

Did you know that the 28<sup>th</sup> September is the International Right to Know day?

This date is when freedom of information organisations from around the world come together for the FOI Advocates Network. This is a global coalition working together to promote the right of access to information for all people and the benefits of open, transparent, and accountable governments.

### What does this mean for my organisation?

Requests for non-personal data can be made using the Freedom of Information Act 2000. The requests can come from anywhere in the world and are treated as 'requestor blind' meaning that only the request itself is looked at for release, regardless of who is requesting it. Each request has a specific deadline of up to 20 working days for you to respond.
