#### Purpose

#### **Background**

The Self-Care policy has been discussed at previous JAPC meetings and has now been agreed by all 4 Derbyshire Governing Bodies. The wording regarding exceptionality has been changed in line with comments made at the last meeting but JAPC is asked to consider whether the wording agreed should be the same in both the GF position statement and the self-care policy.

## **Financial implications**

Potential savings are difficult to estimate as many of the drugs considered are used for both minor ailments and chronic conditions. However, some savings would be expected (in excess of £250,000 per annum across Derbyshire) and, in the long term, savings due to reduced GP appointments and better use of NHS resources would be expected to be much more important.
