Access to GPs to patients – reasonable needs?

In November 2017, NHS England issued guidance to commissioners regarding the practices definition of how 'reasonable needs of patients' in providing or arranging access to essential and additional services delivered under the GMS contract. Hospital guidance – onward referrals

New guidance on onward referral has been published. Changes to the contract in 2016 allowed for onward referral of patients by clinicians. in secondary care certain situations, rather than having to always require referral back to the GP. The guidance is designed to support doctors locally in applying the change appropriately. As a reminder, new guidance was also published recently on the responsibility for prescribing and principles for shared care. All guidance can be found on the BMA website, including the Quality First pages with the template letters to support LMCs and practices in reporting contract breaches.

GPDR – Medical record requests 'vs' medical reports?

Under the new GPDR regulations, in most cases, patients must be given access to their medical records free of charge, including when a patient authorises access by a third party such as a solicitor. A 'reasonable fee' can be charged if the request is manifestly unfounded or excessive. However, these circumstances are likely to be rare. If the request is for a medical report (rather than a SAR) then this falls under the Access to Medical Reports Act (AMRA) and should be

handled in the usual way. The GDPR does not change the AMRA.

Driving Licenses for older citizens – changes!

We have become aware that the DVLA has recently changed the paperwork that it sends out to older citizens applying for a renewal of their driving licence. Unhelpfully, the letter contains the line 'Before returning the application you should check with your doctor(s) that you are able to satisfy the medical standards for driving'.

This has led to patients in other areas either ringing surgeries requesting letters or booking appointments to discuss their driving. This issue has been raised nationally with GPC and the DVLA to get this letter changed as we recognise this creates unnecessary workload for practices.

In the meantime, there are a number of options that have been suggested; a private medical could be offered, or the patient could signposted to attend one of assessment centres (Kingsway Hospital, Derby is the nearest - Older Driver's Website. This does not negate the GP to Patient relationship in discussing health issues in relation to driving during usual consultations and the GP has a duty of care to advise the patient (and if needed the DVLA) of any medical and health issues that may impact on their safety (or others) as relevant.

New national data opt-out

Selecting whether patient's confidential information and data can be used for research and planning purposes. NHS Digital has written to practices to explain that they will automatically converting patients' existing type 2 objections to the new opt-out from 25 May 2018. NHS Digital will be sending practices a pack of patient communication materials to help explain the changes, and have developed a checklist of actions that practices might want to take, available here. Capita Performers List delays

GPs who are left unable to practise because of problems with Capita's management of the Performers List are having to wait four months without work before being able to claim compensation. NHS England, which commissions PCSE services to Capita, said settlements would be offered on a "goodwill basis" only in "exceptional cases", where applications had been delayed by more than 16 weeks.

GPs struggle to offer routine appointments

A <u>Pulse</u> investigation suggests one in six GPs are under such pressure they have resorted to halting routine appointments or limiting appointments to 'emergency only' at some point in the last 12 months. The survey of 800 doctors found some practices are not able to offer appointments for a month, and will screen every patient who calls by telephone to assess if they need.



Shortage of diamorphine for NHS patients

The Department of Health and Social Care (DHSC) and NHS England have been made aware of a manufacturing issue from one of their suppliers of Diamorphine 5mg and 10mg injection. There are currently two suppliers of Diamorphine injection in the UK; Accord and Wockhardt. Click here to read more.

Being a host practice for an international GP trainee or GP for a maximum of 4 weeks is a fantastic way of learning about another healthcare system, to showcase our own system to make new friends. provides an opportunity to provide evidence within CQC requirements, in particular W8 Learning, improvement and innovation.

The Hippokrates Exchange programme is currently open to trainee GPs or GPs within the first 5 years of qualification. This is an international scheme, with over 16 years of experience, developed by the Vasco da Gama Movement, an independent European forum for GP trainees and junior GPs.

The host practice chooses how to structure their exchange, how many visitors they accept and which periods in the year are most convenient. Participants are observing only and are normally expected to fund their own accommodation, travel and living costs. Participants are allocated individually and will not contact you directly.
