The temporary changes made to GP Connect and Summary Care Record Additional Information in response to the COVID-19 pandemic will continue in place beyond the end of the Control of Patient Information (COPI) Notice.

Please remove all mentions of COPI from your privacy or transparency notices for these services after 30 June 2022, when COPI expires.

We have <u>GP Connect</u> and <u>SCR</u> notices for you to follow or link to from your organisation notices.

Reminder - Ability to upload HTML files into NHS e-RS is being withdrawn

The ability to upload HTML files into NHS e-Referral Service (e-RS) is being withdrawn from 12 August (subject to testing) due to potential security risks. This will ensure e-RS adheres to the most robust cyber security rules.

You should only upload <u>supported file types</u> into e-RS. Advice on how to save unsupported files such as HTML to different formats to allow them to be uploaded into e-RS can be found on the <u>NHS Digital website</u>.

COVID Oximetry @home

From 1 July, we will no longer be centrally collecting and reporting on data from COVID Oximetry @home services. This will reduce data burden on the workforce, who will not need to submit weekly situation reports going forwards. The daily feed of positive COVID-19 patients will also be stopping in line with the end of COPI notices.

A national supply of oximeters remains available to support COVID Oximetry @home services by <u>request</u>. An updated COVID Oximetry @home standard operating procedure will be available shortly. Please contact <u>england.home@nhs.net</u> with any queries.

New guidance to support digital GP Contract requirements

In October 2021 new requirements for general practice came into effect in the GP Contract relating to digital services. To help explain what these requirements are and to support the implementation of them you can access new guidance for GP practices.

As part of the requirements, your practice must offer and promote:

- an online consultation tool
- a video consultation tool
- · a secure electronic communication method
- an online facility to provide and update personal/contact information.

You must also signpost patients towards your online consultation tool and the NHS Symptom Checker from your website and other online presence.


